Introduction

Enroll Indy is a nonprofit organization dedicated to serving Indianapolis families by providing a streamlined, one-stop enrollment system for Indianapolis Public Schools and charter schools within Center Township. In addition to simplifying enrollment, Enroll Indy offers clear, accessible school information to help families make informed decisions, and uses data management and analysis to support school improvement efforts. The organization fulfills its mission through the following services:



The Enroll Indy School Finder is an online tool that helps families explore and compare their school options. It includes all schools within the Indianapolis Public Schools district and charter schools in Center Township. Each school maintains a profile highlighting its unique offerings. Families can search based on location, academic programs, transportation options, school hours, and other important details—eliminating the need to contact multiple schools individually to gather this information.



OneMatch is Enroll Indy's annual school application and lottery process. OneMatch replaces more than 100 different school applications and deadlines, ensuring that all students can apply for schools on one application with one timeline and receive one school match. The application opens in the fall, and includes two lottery rounds. Dates for each round are published on our website.



The Enroll Indy Open Seat Portal offers families real-time information regarding open seats still available after the OneMatch lottery rounds have closed. The portal, accessed via the Enroll Indy website, eliminates the need to call schools to find an open seat.



Enroll Indy also serves as the clearinghouse for available school seats throughout the year. Families who need a new school can call Enroll Indy for help. Our specialists serve as impartial concierges who assist families in finding a school that meets their needs.

Enroll Indy Policies

OneMatch Overview

OneMatch is Enroll Indy's K-12 lottery system that allows families to apply to up to ten schools with one application and one timeline. Students who complete an application receive one school match for their child.

The OneMatch process consists of two lottery rounds.¹ After each round's deadline, Enroll Indy runs a lottery that determines placement for applicants based on the following variables:

1. The student's rank of preferred programs
2. The student's priority according to the school's enrollment policy (such as geography, sibling status, etc.)
3. The student's random lottery number.

Applicants living within the Indianapolis Public Schools district are guaranteed a seat in their geographic zone. Any student who wishes to attend an Indiana charter school may apply given they live in the State.

The application is available on any internet-connected device. Paper applications are not available. Schools may provide an interest form to gather information from interested students, but this is not considered a valid enrollment application. The only official application is accessed through the Enroll Indy website from a computer or mobile device. Applicants who need assistance or are without an internet-connected device, can apply by calling Enroll Indy. After the lottery has been completed, results are evaluated for accuracy before being released to schools. On the published results date, families may log in to their Enroll Indy account to view their student's school match.

The dates of each OneMatch round are posted on the Enroll Indy website.

Single Best Offer

The matching algorithm used by Enroll Indy is known as the "Single Best Offer" system. This approach ensures that each student receives one school match per lottery round, meaning students cannot hold multiple seats at the same time. **The system does not use waitlists.** If a student is not matched with their top-choice school or if a family chooses not to accept their current match, they may submit a new application in a future round to pursue a more preferred option.

¹ Indianapolis Public Schools (IPS) will offer 60% of all PK and K in Round 1 and 100% of PK and K in Round 2. One hundred percent of 6th grade seats will be made available in Round 1 and Round 2. For 9th grade at IPS Choice programs (Arsenal Tech, Crispus Attucks, Shortridge, and George Washington), 100% of seats will be made available in Round 1 and Round 2.

Receiving a Seat = Surrendering Current Seat

If a student who currently holds a seat in an Enroll Indy-participating school applies and matches to another participating school, the student automatically loses their current seat. Likewise, if a student receives a seat in Round 1 but applies to a different school and receives a match to that school in Round 2, they give up their seat from Round 1.

Who Must Complete a OneMatch Application?

- All students new to school in Indianapolis, including incoming pre-K students and kindergarteners who wish to attend an Enroll Indy participating school.²
 - Example: A 5-year-old attending school for the first time, or a 3rd grader who is new to Indianapolis.
- All students in terminating grades that are not a part of a Feeder Program.
 - Example: An 8th grader at Andrew J. Brown, which does not have a high school program.
- All students who wish to attend a different participating school in 2026-27 than they are attending in 2025-26.
 - Example: A 2nd grader at an IPS school who would like to attend a charter school for 3rd grade.

Who Does Not Need to Complete a OneMatch Application?

- Students who wish to remain at their current school.
 - Example: The parent of a 2nd grader who wishes to keep their student at their current school for 3rd grade does not need to reapply.
- Students who wish to attend a non-IPS district school, private school, or any other non-participating school.
 - Example: An 8th grader who plans to go to a private school or their township school does not need to apply.
- Students in terminating grades that want to continue to the next grade in their Feeder Program.
 - Example: An 8th grader at Irvington Community Middle School who would like to continue on as a 9th grader at Irvington Preparatory Academy.

² In the 2024-25 school year, IPS implemented Rebuilding Stronger and eliminated all neighborhood schools. No student will be assigned a default school based on their address, therefore all new students to IPS must submit a lottery application to receive a school assignment. OneMatch Application Process

School Finder

Prior to filling out the application, families are encouraged to explore the Enroll Indy School Finder to determine which school may be the best fit for their student based on the family's needs and desires. A guided search can filter school choices by address, grade levels offered, school type, or program offerings.

School Options

The School Finder and the OneMatch application will display three types of school options available for families denoted by the following key:

School Type Key

-  IPS In-Zone School; Guaranteed Transportation
-  Charter Public School; Transportation Possible
-  IPS Out-of-Zone; No Transportation Available

In-zone schools are determined based on applicants address. Students attending an in-zone school will receive transportation.

When a parent is selecting their school choices, a color-coded icon is displayed next to each school indicating whether the school is an IPS In-Zone School, a public Charter School, or an IPS Out-of-Zone School. IPS In-zone schools are determined based on an applicant's address and offer guaranteed transportation unless they live within a walking zone.³

Special Transportation Note Regarding IPS Zones

Students are classified as walkers if they live within the following distances:

- K-5th graders: Less than 1 mile from school
- 6th-8th graders: 1.25 miles or less from school
- 9th-12th graders: 1.5 miles or less from school

Accessing and Completing an Application

OneMatch is an entirely web-based system. Paper applications are not available. To access the application, families may visit enrollindy.my.site.com. The family will follow the steps below to complete the application:

Create a Family Account

- Create a family login, including an email and phone number.

³ Transportation options vary by charter school. Parents can contact the school directly for more information regarding transportation.

- Choose **Send Verification Code** and submit.
- Check the email or text messages for the 5-digit temporary passcode.
- **Enter the code on the account verification screen and click Verify.** This will take families to the new account home page.
- The screen will display the option to Learn, Apply, or Match. When ready to apply, families must complete the **Family Information Profile and click Submit** at the bottom right of the page. This will return families to the previous page.

Add a Student

- Follow the **Add students** link in the Apply column.
- **Search first under “Find My Student”**
- If the student is not found, choose **Create New Student.**
- Complete the Student and School Information section.
- Click the **Next** button.
- Families must read the information on the Applying For Schools page, and then click the **Ready to Apply** button.

Apply

- On the **Select Your Schools** page, from the left side menu, families may select schools they wish to apply to for each student.
- Use the left and right arrows to add or remove them from the Selected Schools menu. Before selecting the Next Button, families should double check that the schools are in the order they would like and then click the **Next** button.
- Families may indicate sibling considerations under each school, such as whether the student has siblings currently attending the school, a parent who is on staff or the board at the school, and whether the family wants Family Match consideration.
- **Click the Submit Application** button. Families must verify the information on their application as it appears on the pop-up screen. If it is correct, click the **Yes** button.
- Repeat the Apply Now process for each student.

Applicants who need assistance or are without an internet-connected device, can apply by calling Enroll Indy at 317-426-3234.

Sibling Considerations and Family Match

The following sections provide important details to consider while filling out an application.

Indicating Siblings Attending an Applicant School

After selecting schools, the user can indicate if their student has a sibling at the school they wish to attend (or a sibling who graduated from the school they wish to attend - charters only). The user enters the sibling’s name and grade level. This information is verified by Enroll Indy

and the sibling priority will be applied to the application. *For more about sibling eligibility, see the Eligibility and Priorities sections of this manual.*

Indicating if an Applicant is the Child of Staff or Board Member

After selecting schools, the user can indicate if their student has a parent employed by the school/district to which they are applying. The user will enter the parent's first and last name.⁴ This information will be verified by the school/district and the priority will be applied to the application. Please see the Appendix for each school's enrollment policies.

Family Match

Families applying for more than one student can choose to opt in to Family Match, a feature designed to prioritize keeping siblings together at the same school. The following guidelines apply:

- By enabling Family Match, families are indicating that keeping their students together is more important than receiving a top-choice school for each child individually.
- If one student qualifies for their top-choice school but a sibling does not, the system will skip the top choice and attempt to place both students at the next highest-ranked school they have in common.
- To use Family Match, families must rank the same schools in the same order on each student's application. If the school lists do not match, Family Match will not be applied.
- Families who do not enable Family Match are indicating that their students can attend different schools, and each application will be considered independently.
- Families with twins or multiples who want them placed together should use the Family Match option.

Editing An Application

Families can make changes to their application at any time before the enrollment round closes. For support, they may also contact Enroll Indy's enrollment specialists. Once the application window for a round closes, no further changes are allowed.

Enroll Indy's Right to Revoke Seats

Enroll Indy verifies all information submitted on applications, including addresses, student birthdates, and enrollment priorities such as sibling or geographic preference. If any part of the application is found to be false, Enroll Indy reserves the right to revoke the student's seat.

⁴ *IPS and Butler University employees will also be asked to list their work ID number.*

All families are strongly encouraged to carefully review the application before submitting to ensure that the grade level and all other information are accurate. Submitting an application with an incorrect grade level may result in a student not receiving a seat or having a seat offer revoked. The only exception is for students who applied for 4th grade but are retained in 3rd grade due to IREAD results, in which case Enroll Indy will adjust the grade level accordingly. However, if a family knowingly applies for 4th grade to avoid retention, the student's seat may be revoked. If the school does not have space in the appropriate grade level, they are not obligated to enroll the student. Overenrollment in 3rd and 4th grade is permitted only for currently enrolled students.

Only individuals with proper authorization may submit an application on behalf of a student. If an application is submitted without parent or guardian consent, the student's seat may be revoked.

Verification and Results Review

After the enrollment window closes, Enroll Indy processes applications and uploads lottery results to the OneMatch Portal. Schools are given a three-day window to review their rosters for accuracy before results are finalized.

If no discrepancies are reported to Enroll Indy by the deadline, the results are finalized and released to families. Families are notified via email and text and can log into the OneMatch Portal to view their school match and follow the next steps to claim their student's seat.

Claiming or Declining a Seat

If a family chooses not to accept a seat, they can click the "Decline" button in the portal. Declining a seat is final and releases the seat back into the system. Once a seat is declined, the student no longer has a guaranteed placement in the Enroll Indy system.

To secure a student's seat, families must complete the next steps outlined by each school in their Match Results email sent by Enroll Indy. These steps may include specific registration links or other instructions. Schools are required to give families at least 30 days to complete these steps after Rounds 1 and 2 of the OneMatch lottery. After that period, schools may choose to release the seat for the next lottery round or for summer enrollment, whichever is applicable. For summer enrollment, the deadline to complete next steps is typically 7 days.

It is the school's responsibility to make every effort to contact families before releasing a seat. Enroll Indy will only remove a student from a school's roster if the school has made diligent attempts to reach the family, or if the family contacts Enroll Indy directly to decline the seat.

Registration vs. Enrollment

While Enroll Indy matches students to schools, registration is managed by the district or school due to the variety of student information systems (e.g. Powerschool, Alma, etc.) Enroll Indy welcomes schools to provide their registration links to be included in the emails sent following each round of the OneMatch lottery or when families use the Open Seat Portal.

It is the responsibility of each school to comply with state and federal requirements for student registration, including the collection of necessary documents. The collection and management of student records, other than enrollment, is outside the scope of Enroll Indy.

OneMatch Eligibility Policies

IPS Pre-K Eligibility

Students must turn 4 years old on or before August 1 of the school year for which they are applying for Pre-k to be eligible to attend an IPS Pre-K program. IPS Pre-K programs do not provide transportation.

- All families who wish to attend an IPS Pre-K program are highly encouraged to apply for an On My Way Pre-K voucher.⁵ There is a fee to attend unless families receive voucher benefits. Visit [Pre-K Enrollment – Indianapolis Public Schools](#) to learn more about the monthly cost.
- A child may only attend IPS Pre-K once.

Kindergarten Eligibility

All students who turn 5 years old on or before August 1 of the school year to which they are applying for kindergarten are eligible to attend kindergarten. However, schools are allowed to grant waivers to students who turn 5 after August 1, and to set their own policies related to waivers. Each school is responsible for updating their Enroll Indy School Finder which lists the kindergarten cut-off date. Special considerations are listed below:

- IPS grants an automatic waiver to all students who turn 5 on or before September 1 of the school year for which the student will start kindergarten.
- Any families with students who turn 5 after September 1 and want to attend an IPS school need to apply for a waiver and go through an assessment process by contacting giftedandtalented@myips.org.
- Families with students who turn 5 after October 1 will not be able to submit a kindergarten OneMatch application without first receiving a waiver from a charter or district and then contacting Enroll Indy for assistance completing the application.

Center for Inquiry Students Returning from International Experience

CFI students who leave the school for one year or less for international experience (consistent with IB curriculum) may be re-admitted into the program without applying. Schools will not hold seats for these students, but they may overbook to accommodate them.

Dual Language Program Eligibility

All students in grades K-2 are eligible to apply for Theodore Potter during the OneMatch rounds or during summer enrollment. Spanish proficiency is required to attend grades 3-5 at Theodore Potter and grades 6-8 at Harshman. Enroll Indy collaborates with the schools for a list of

eligible students. Parents interested in dual language programs should contact IPS for more information.

Merle Sidener Gifted Academy/H.L. Harshman High Ability Middle School

Each student in the district will take a test that determines eligibility to attend Sidener and Harshman's high-ability programs. Only students who qualify as high ability in either English or math are allowed to enroll. Students at non-IPS schools, or students who transferred to another school and wish to re-enroll must check with the high ability schools' administrators to see if they are eligible for the program. Enroll Indy accepts applications from all students but only processes OneMatch applications for those confirmed as eligible by IPS high-ability staff.

Exchange Students

Students from other countries who are participating in an exchange program should contact their desired school to see if they accept foreign exchange students prior to filling out an application. Receiving a seat during the OneMatch lottery round does not guarantee an exchange student will be able to attend the school.

Transfer Eligibility Policies

Transfer Policy for IPS High School Students

Indianapolis Public Schools has four IPS-specific high schools, meaning any student within IPS is guaranteed a seat at one of these district schools: Arsenal Technical High School, Crispus Attucks High School, George Washington High School, and Shortridge High School.

The following rules apply to students who wish to transfer to another high school within IPS or to a different program within their current high school:

- All students attending one of the schools listed above may change schools a maximum of one (1) time during their academic career.
- All students may only change choice programs located within the same building once, at the principal's discretion. This is handled at the school level, not through Enroll Indy.
- As of the last day of their junior year, current IPS rising seniors are not allowed to transfer to another IPS high school.
- Students who have already used their IPS high school transfers will be marked ineligible in the Enroll Indy system during OneMatch and their applications for another IPS choice high school will not be considered. This applies to the late enrollment period, as well.
- A student who previously attended an IPS choice high school but is no longer attending, may only return to IPS by enrolling in the same school and program in which he/she was previously enrolled.

- Students who wish to transfer at semester break must have counselor approval before Enroll Indy can make the transfer.

If a current IPS student wishes to transfer to a charter high school within the Enroll Indy portfolio, they are free to do so if there are available seats at the school they wish to attend.

Transfer Timeline:

- Current IPS students who wish to transfer to another IPS school for the next school year, must apply through Enroll Indy OneMatch lottery or claim an open seat during summer enrollment, before the first day of school.
- Students who wish to transfer during the school year, must receive counselor approval and do so during the designated transfer window set by IPS. Students or families may visit their school counselor to learn more.

Transfer Policy for Shortridge High School

As an International Baccalaureate (IB) school, Shortridge only accepts new students into grades 9, 10, and first semester of 11th grade. (IB programs require a minimum of three semesters to graduate.)

Transfer Policy for IPS Students in Grades K-8

IPS allows K-8 students one mid-year transfer between IPS schools plus additional transfers for transportation-related reasons.⁶ If a current IPS student wishes to attend a charter school mid-year, they may call Enroll Indy to see if there are open seats at their desired school.

Transfer Policy for Purdue Polytechnic High School and PPHS Lab Students

A student may not transfer between Purdue Englewood and Purdue Lab after the first day of attendance until the end of the semester.

Transfer Policy for IPS Students with Exceptional Circumstances

To support stability for both schools and students, IPS allows mid-year transfers only in rare and exceptional circumstances. The most common reason for approving a mid-year transfer is to address safety concerns. Other transfer requests will be reviewed on a case-by-case basis.

⁶ IPS will allow students to transfer between IPS schools mid-year additional times if doing so would get them transportation when they don't currently have transportation to their school. This could happen in one of two cases:
 1) The family recently moved to a different zone and no longer receive transportation to their current school so need a new IPS school with transportation or 2) The family chose an out-of-zone school without transportation but now need transportation, so they need to select a school where they would receive transportation.

Student Transfers Without Parent/Guardian Involvement

If a parent can demonstrate that a student completed the Enroll Indy OneMatch application or called Enroll Indy to apply to another school without guardian participation or permission, the student can return to their previous school.

Lottery Priorities

An applicant who has a lottery priority, and indicates it on their application, is given preference within the lottery above an applicant who does not indicate or who does not qualify for a priority.

The following terms and definitions represent the lottery priorities used for Enroll Indy schools. Not all priorities apply to all schools.

Affiliated Pre-K Program (Charters)

Applicants who attend a charter-affiliated pre-K program receive priority. (For a list of affiliated pre-k programs, see the Appendix.)

IPS Pre-K Programs

Students who received an IPS Pre-k seat for a particular school year are automatically guaranteed a seat in that school for all subsequent years as long as they do not apply out to another school. If a family wishes to attend a different school for kindergarten, they will need to participate in OneMatch. Additionally, families applying for a Pre-K seat will receive the same priorities as K-8 IPS students.

Children of Butler University Staff

Children of Butler University employees are given priority to Eliza Blaker School 55 and William Bell School 60.

Children of Charter School Staff/Board Member

Children of staff members and of current or founding board members of a charter school receive priority admission to that school or a school within that charter school network.

Children of IPS Employees

Children of IPS employees receive priority to IPS schools. This includes employees at the district or school level but does not include charter schools.

Geographic Priority

There are several geographic priorities used by participating schools. Some schools have multiple geographic priorities, while others have none. The priorities of each school are listed in Appendix I.

McKinney-Vento

Students who identify as homeless or displaced have protections under federal law. Enroll Indy allows students to identify themselves as homeless or displaced during the application process. This allows Enroll Indy to flag students who may need services provided under McKinney-Vento. This information is shared with the sending and receiving schools. After the student enrolls, schools must follow procedures under the McKinney-Vento Act.

Sibling Priority

Schools can choose to prioritize siblings of current students. Siblings are defined as students residing in the same household and/or students sharing the same parent/guardian. The intention of sibling priority is to keep families together when possible. An applicant must include the first and last name and current grade of sibling on the OneMatch application in order to be eligible for this priority.

See the list below for more details:

- Sibling priority can be applied to any sibling of a current student provided that the current student presently attends the school and will attend the school the following school year.
- Students who have matched out of a school in Round 1 of the lottery do NOT earn sibling priority for their siblings at any school in Round 2 of the lottery.
- Students in terminating grades (such as an 8th grader in a K-8 school) do NOT earn sibling priority for younger siblings, except for some charter schools who may accept siblings of an alumnus.

Sibling Legacy Priority (Charter or Innovation-Charter High Schools Only)

Some charter schools offer a sibling legacy priority. Under this priority, siblings of all current students, including 12th graders, and former graduates of the school receive a priority. Applicants must include a student's first and last name, and grade of the sibling. If the applicant is a sibling of a graduate, the applicant must select "Graduate" in the grade dropdown list.

Summer/Late Enrollment Policy

May Maintenance, formerly known as *The Dead Period*

In May, students cannot officially enroll in any Enroll Indy schools due to roster reconciliation from Round 2 of the OneMatch lottery. Additionally, Enroll Indy uses this month to switch the online system from the current school year to the upcoming school year.

Interest Lists but No Wait Lists

Schools may keep an interest list (not a wait list) of students who want a seat following the Round 2 registration deadline. If open seats remain, schools can notify **all families** who showed an interest in enrolling at their school. Schools will have three days to enter any student into Salesforce before the Open Seat Portal goes live to the public.

Open Seat Portal

Enroll Indy uses an online portal on our website which reflects the number of seats available at each school. The portal generally opens at the beginning of June and closes the first week of September. The exact dates are published on the Enroll Indy website.

The Open Seat Portal is open 24 hours a day and is updated in real time. These seats are available on a first-come, first-served basis. Students new to the area or those interested in transferring to another Enroll Indy participating school can claim an open seat directly through the portal or by calling Enroll Indy. When a student transfers to a new school, the student is discharged from their former school and is no longer considered a student at that school.

The following programs such as K-8 schools with special eligibility requirements and some high school grades do not offer online enrollment through the Open Seat Portal, as Enroll Indy must verify that a student has qualified to attend or is permitted to transfer:

- All IPS Pre-K Programs
- Sidener and Harshman High-Ability schools
- Theodore Potter and Harshman Dual Language schools: Grades 3-8
- IPS High Schools: Grades 10, 11, 12

Ongoing Enrollment Policies

Enroll Indy as the Official Enrollment Platform

In addition to running the OneMatch system and the Open Seat Portal, Enroll Indy manages ongoing enrollment for all schools in the Enroll Indy portfolio.. Any time a student needs a seat during the school year, whether transferring between schools or moving into the city for the first time, that seat is assigned through Enroll Indy's central system. Families can call Enroll Indy for assistance or walk in to any Enroll Indy participating school to inquire about availability. If a school has open seats, the School may submit a transfer/discharge request directly in their Salesforce account as well as their SIS.

Students who live out of district can enroll in any IPS school until the State's attendance count day (ADM) usually in mid to late September. Once count day has passed, students from outside of the IPS District cannot enroll in any IPS schools unless their sibling attends IPS or their parent is employed by IPS. Charter schools accept students from anywhere in the State throughout the year as long as they have seat availability.

Policy regarding Expulsions

Enroll Indy does not maintain or enforce expulsion policies. If a school receives an email from Enroll Indy indicating that a student has been added to its roster, it is the school's responsibility to obtain the student's records, including discipline reports. If the receiving school discovers that a student is currently serving an expulsion and is not eligible to enroll until the expulsion is lifted, the school may notify Enroll Indy to remove the student from its roster. If a student enrolls and has withdrawn from their former school to avoid expulsion, we recommend that the receiving school ask the former school to document the incident and work with the charter school authorizer or the District to resolve any issues.

Withholding/Holding Back Seats

Charter schools must offer all available seats in each enrollment round and are not permitted to withhold seats under charter law. IPS district policy allows schools to offer a portion of their entry-grade seats during each round.

Feeder Pattern Policies

Policy for Charter Schools

Some charter schools have feeder programs which allow students in terminating grades to feed into an affiliated or network school. This only applies to charter schools within the same network or those schools who are co-located. For a list of all Feeder Patterns, see Appendix II.

Feeder/Pipeline Guarantee for IPS Schools

Students who receive an IPS Pre-k seat are automatically guaranteed a seat in that school for all subsequent years as long as they do not apply and get matched to another school. If a family wishes to attend a different school for kindergarten, they will need to participate in OneMatch.

Students who attend a school that has an automatic pipeline to a feeder school may login to their Enroll Indy account to view their current school and future school. Families who wish to attend the displayed future school do not need to complete a OneMatch application. Applicants who want to apply to a different school, should submit a OneMatch application. An applicant will only give up a seat to their feeder school if they are matched to a school on their OneMatch application.

All IPS K-5 or K-6 students receive a guaranteed seat at an IPS middle school in the student's zone. To see a list of IPS pipeline guarantees, see Appendix III.

Special Case: IPS Shortridge Feeders

- Eighth graders enrolled at IPS IB middle schools (Longfellow, Northwest, Howe, and Broad Ripple) as well as eighth graders at Edison Schools of the Arts have guaranteed entry to Shortridge High School.
- **To claim this guarantee, students from these schools must apply in Round 1.** If a family does not apply in Round 1 they are no longer guaranteed a seat at Shortridge High School.

School Administrators Section

Additional Policies & Procedures for Schools

Enroll Indy as Sole Enrollment Process

According to the Agreement between Enroll Indy and participating schools, herein referred to as School(s), Enroll Indy should be the only enrollment mechanism used by a School. Separate enrollment applications or processes are outside the Agreement. Schools that use an interest form should ***make clear that the form is not an application.***

To preserve the integrity and equity of the unified enrollment process, schools must not directly enroll students into their student information systems such as PowerSchool or Alma. All student enrollments are required to be processed through Enroll Indy before or at the same time that the student is entered into the student information system.

Enroll Indy expects each school's enrollment webpage to include a clear link to the Enroll Indy website to ensure enrollment fidelity across all Enroll Indy participating schools.

Technology System Access and Security

Enroll Indy uses Salesforce as its central enrollment platform for student enrollment information as well as:

- collecting and storing student applications
- tracking seat availability
- maintaining current and future year student rosters for each school
- managing the transfer and discharge process
- reporting enrollment data to designated district and charter authorizers

Schools may not attempt to access or allow access to Enroll Indy Systems – meaning data, the Unified Enrollment system, the Salesforce platform, and Enroll Indy's SFTP site – that is not required for the performance of the services provided by Enroll Indy and shall only use the Enroll Indy Systems with applicable federal, state and local law, including state data privacy laws.

Salesforce Access and Training

Enroll Indy provides each school with one free Salesforce license. Additional licenses are available for \$100 annually. Administration Users may be assigned to multiple schools under one license. With the license, schools can track application data, request transfers or discharges from their rosters, and update their [School Finder](#) profile information.

Enroll Indy will provide Salesforce professional development and training in group settings and individually. Schools are responsible for understanding and appropriately utilizing the Enroll Indy Salesforce system. Training attendance is mandatory for new users to maintain access and compliance with enrollment policies and procedures.

Multi-Factor Authentication (MFA)

Multi-Factor Authentication (MFA) is a dual login method that requires a user to approve a login request on their cellphone to access their Salesforce account. All Salesforce users must use MFA via the Salesforce Authenticator app. Salesforce enforced this policy to increase security as it is critical to protect customer data. Enroll Indy requires all of their Salesforce users to complete the MFA registration process during any license renewal, license changes, or new license creation. All Enroll Indy Salesforce users are required to download and use the “Salesforce Authenticator” app as the login method to access their account.

Security, Data Protection, and Incident Response

In addition to MFA, Schools shall implement and maintain commercially reasonable administrative, technical, physical, and organizational safeguards that (i) are consistent with industry standards and (ii) comply with all applicable federal, state, and local laws to protect all Enroll Indy Systems and ensure the availability, integrity and confidentiality of all student data all other confidential data in the possession of the School. By employing appropriate methods, including encryption and encrypted devices, and secure communication lines, Schools secure the privacy and security of data and minimize the risk of unauthorized access to the Enroll Indy Systems.

Schools must notify Enroll Indy within twenty-four hours if there was actual, attempted or unauthorized access to – or use of – data, the UE system, the Salesforce platform, and/or Enroll Indy's SFTP site. Schools shall reasonably cooperate with Enroll Indy in responding to such an Incident and will pay the costs and expenses of investigation, remediation, notification, and penalties associated with the Incident.

Enroll Indy School Finder Requirements

The Enroll Indy School Finder is a free service offered by Enroll Indy to help build awareness of each school, allowing families to gather important information as they consider their school choices. The Finder is available in English and Spanish and may be translated in other languages. Schools have access to update most of the content on their School Finder profiles in Salesforce. Schools are responsible for updating their profile with accurate information in line with their school's offerings. ***Schools who would like to publish rankings on their profile need to include the source and date of the ranking or distinction directly on their profile.***

Setting Enrollment Targets

Schools participating in Enroll Indy's unified enrollment system are responsible for setting a series of grade level enrollment targets to be used throughout the year. If schools do not submit their enrollment targets by the given deadline, Enroll Indy will use their previous year's target enrollment numbers for the lotteries and late enrollment.

Using Historical Data for Enrollment Target Setting

Each fall, Enroll Indy provides Schools with historical enrollment data to inform enrollment target setting and identify trends. Schools are encouraged to set high match targets during Rounds 1 and 2 of the OneMatch lottery. Higher early targets help maximize matches and ensure rosters are filled by the start of the school year, reducing the need for last-minute summer enrollment efforts.

Target Types and Definitions

Match Target (Rounds 1 & 2)

The total number of seats a school aims to fill through the lottery process. This number:

- Should be higher than your ADM (Count Day) target to account for attrition in current and new students.
- Cannot be increased once submitted. This policy assures equity and transparency to families as well as to all participating schools.
- May only be lowered between rounds or during summer, never below your capacity or minimum enrollment threshold.
- Is used by Enroll Indy to run the OneMatch algorithm.

First Day of School Target

Schools may adjust their target downward in June or over the summer to reflect updated enrollment projections. These adjustments are at the school's discretion but may not fall below the school's capacity/minimum enrollment requirement.

Active Targets

In each school's Salesforce account, the number of students listed as the Active Count should match the number of students in your Student Information System (PowerSchool, Alma, etc.). In Salesforce, the "Seats Available" refers to the number of seats showing as open and available to new students.

Application Demand Reporting

Enroll Indy supplies weekly demand reports to schools during OneMatch rounds, including the number of applications received per grade level and priority category. Real-time demand data is also available via each school's Salesforce dashboard. Schools are only allowed to view their own dashboards and data for other schools/networks/districts will not be shared across the portfolio. Schools may request additional customized data for a fee. Enroll Indy can provide a list of students who applied to your school, given they have opted in to share their information. We do not share how each family ranked your school (1st choice, 2nd, 3rd, etc.). Users will also be able to see how many current students (along with their grade level) have applied to a different school, as long as the school they applied to is within the Enroll Indy portfolio.

Roster Reconciliation Post-Lottery

After each lottery window closes, Enroll Indy uploads the results of the lottery (matched students) to the OneMatch portal and provides schools three business days to review rosters for accuracy. Enroll Indy strongly encourages schools to review the rosters for the following:

- Any test students created that need to be deleted/discharged
- Verification of student priorities
 - e.g. A student matched with a sibling priority and they don't have a sibling in your network or school
- Students who do not appear on the roster but have told school staff they had applied
- Mismatched birthdate and grade level
- Overall numbers meet expectations based on the demand reports received and the targets set

If Enroll Indy does not receive an email with potential discrepancies by the given deadline, the results will be finalized and uploaded to the Enroll Indy portal. Families are notified by email and text message to log into the OneMatch portal and click "**View Results**" to see their school match and the required next steps to claim their student's seat.

Next Steps/Registration

While Enroll Indy serves as the official enrollment vehicle for families to claim a school seat, each school is responsible for providing families with their registration process. As a courtesy, Enroll Indy includes each school's registration steps in the OneMatch results emails. Each school or district representative is responsible for updating the "Next Steps" section in Salesforce by the Enroll Indy deadline. An email from Enroll Indy is sent with these deadlines before the end of each round of the lottery, and prior to the opening of the Open Seat Portal.

Roster Accuracy and SIS Integration

Enroll Indy has established an automated integration between each School's Student

Information System (SIS)—such as PowerSchool or Alma—and Salesforce. Integration runs nightly, comparing rosters via a secure File Transfer Protocol (FTP) site. Discrepancies generate error reports that both Enroll Indy and schools must address collaboratively.

Key Reminders:

- Enroll Indy does not input data directly into any SIS, and schools are solely responsible for ensuring their SIS reflects accurate enrollment for state reporting.
- **Schools must ensure students are added or discharged in both their SIS and Salesforce—especially during the summer when integration is inactive.**
- Enroll Indy provides training and written instructions on how to add or discharge a student from their Salesforce roster.
- Enroll Indy also supports each school in best practices on how to reconcile rosters between the SIS and Enroll Indy’s Salesforce roster.

Capacity and Backfill Policy

While the term “Grade or School Capacity” (often referred to as “caps”), represents the number of students a school can enroll per grade level, it is not the highest number of students allowed to enroll. For Enroll Indy application purposes, **capacity refers to the minimum enrollment requirement**—the number of students a school must enroll in each grade level based on either:

- District-determined building capacity
- Enrollment figures outlined in a charter agreement or a written, authorizer-approved amendment to that agreement.

In short, **capacity numbers reflect the minimum number of seats that schools are required to backfill should seats become vacant.** This policy ensures that schools meet their public obligation to provide equitable and consistent access to education and prevents the artificial restriction of enrollment below approved levels. By signing the Professional Services Agreement, schools agree to:

- offer no fewer than the number of seats defined by their building capacity (for district schools) or their charter agreement (for charter schools).
- If a student withdraws or transfers, and enrollment drops below the minimum enrollment requirement, the school must backfill up to that minimum—unless legally exempted by an authorizer-approved limitation, as long as those policies comply with all applicable state and federal laws.
- This number is not a capacity as in maximum amount; in fact, schools may overenroll to account for attrition by ADM/Count Day.

Enrollment Exceptions

While Enroll Indy does not allow Schools to raise targets at any grade, there are some exceptions where Schools without an empty seat may be allowed to enroll a student. The Enroll Indy Board of Directors will review these requests on a case-by-case basis in accordance with district and charter authorizer input and all applicable laws.

Some exceptions include:

- A student who is receiving McKinney-Vento services
- A student's expulsion timeline has been completed, and the student wants to return to their school with permission from the school
- A student who was out of the classroom due to a medical issue and would like to return to their original school
- A third grader who was retained due to IREAD scores.

NEW: Policy for IREAD-Impacted Students

This policy ensures that students who are retained in 3rd grade due to IREAD results remain enrolled at their current school, even if it exceeds the school's enrollment target numbers. It also allows students who pass IREAD over the summer to advance to 4th grade, even if 4th-grade seats are full.

Policy Guidelines

Overenrollment for Retained 3rd Grade Students

Any 3rd grade student who was enrolled in an Enroll Indy participating school and is retained due to IREAD results must be allowed to remain, even if it requires exceeding the school's 3rd-grade enrollment targets.

Matriculation to 4th Grade Following Summer IREAD Passage

If a retained 3rd-grade student passes IREAD during the summer testing window, and is promoted to 4th grade, their current school must enroll them in 4th grade, even if the grade is at capacity. This applies only to students who attended the school during the prior academic year.

Restrictions on Overenrollment

These exceptions apply only to students who were already enrolled in the school and do not extend to new applicants or transfers. Schools may not increase their general enrollment targets beyond the cases outlined in this policy.

Transfer Students Who Enter the Wrong Grade to Avoid Retention

Families applying to a new school, who accidentally apply for the incorrect grade or who intentionally apply for a 4th grade seat to circumvent retention, may have their seat revoked. If

the enrolling school does not have seats available in the correct grade level, they are not required to enroll the student. Overenrolling in 3rd and 4th grades is only permitted for currently enrolled students. All families should review their child's application before submitting to assure the correct grade level and all other information on the application is correct.

Reporting Requirement

Schools must submit a list of all students retained in 3rd grade due to IREAD results to Enroll Indy within three (3) business days of receiving IREAD results. This allows Enroll Indy to properly update student records and ensure accurate enrollment tracking so schools do not end up with inflated or inaccurate seat numbers in 3rd or 4th grade.
